COUNCIL COMMENTS

Mr. Keesling states it seems like just yesterday was 9/11 and his prayers and thoughts are with all those who have been impacted.

Mr. Polhemus begins that 23 years ago our Country was changed forever with and enormous tragedy that was September 11th. Losing many innocent lives, we remember them today and everyday.

Mr. Newman shares that he attended the County 9-11 ceremony this morning for remembrance and for the heroes who fought in the War on Terror. He also attended the Hope Sheds Light walk that was founded 11 years ago by Stephen Willis. He expresses the tremendous job Steve does on community outreach and educating the public on the resources that are out there. One resource Mr. Newman would like to have at a future meeting is Veteran's services with a resident Lenny in October's meeting. Mayor and Council welcomed the idea.

Mr. Newman continues with the concern of parking along Riverside in the emergency entrance to Vista Park. Mayor Cuneo lets the Council know that the Chief has put a message out to all officers.

Mr. Saxton thanks the public for coming to the meeting tonight, on the 23rd Anniversary of 9-11 we reflect on the change it had on our world and people. Out of all the bad that occurred the positive of the people coming together was seen. Mr. Saxton hopes that this feeling can be revived.

Mrs. McGee prays for all the lives lost on 9-11 and their families and the people who are still suffering with ailments today because of 9-11. As a parent and a nurse Mrs. McGee expresses that she felt the Cannabis Ordinance adopted tonight was well drafted and thought through.

Mr. Wieck states that although he voted against the ordinance tonight, he would like to thank Mr. Saxton for all the research and coordination of the document. Mr. Wieck attended the 9-11 ceremony with the Commissioners today, it is our responsibility to continue telling our younger generations and educating them on 9-11 so the innocent lives are never forgotten. He then thanks the public for coming out tonight.

MAYORS COMMENTS

Mayor Cuneo shares that he is an 8th grade teacher, and his 13-year-old students were no alive for 9-11. Speaking and teaching them about not only 9-11-2001 but the following days and how America came together. He takes the time to explain to them the impact and effect these days had on the world. The Mayor thanks John Kubilewicz, PBVFC President, and F. Bruce Carney, as well as Robbie Newman for his rendition of the National Anthem.

Mayor states the Pavilion project has been delayed until early November due to a delay at the Manufacturer. High School sports are back in their Fall Season, go out and support the teams and your neighbors. Thank you for everyone coming out tonight.

There were no other comments or questions, and Mayor Cuneo called for a motion to adjourn. Mr. Newman made a motion to adjourn, and Mr. Wieck seconded the motion, all were in favor, the meeting was adjourned.
